Geoffrey Rakoski, Rakoski Enterprises, Inc. closed on a \$12,500 *Tioga County Micro Loan Fund* loan on Tuesday, November 16, 2010 with the *Tioga County Development Corporation*. The \$12,500 loan will be used to help purchase and install an upgrade to the NAPA required equipment and software.

Geoff Rakoski owns the Blossburg Napa Auto Supply and Lawrenceville NAPA stores. The Blossburg NAPA Auto Supply store was started in 1996 with Rakoski's uncle. Rakoski took over the store as sole owner in July 1999. He purchased the Lawrenceville store in 2005.

In October, the *TCDC* Board unveiled a new small business loan program, The *Tioga County Micro Loan Program*. Loans up to \$25,000 may be approved for for-profit business in Tioga County. For more information on the Micro Loan Program see Page 2.

TCDC Offers New Micro Loan Program for Small Businesses

To better inform our Business Members of Public Funding opportunities available, the *TCDC eNews Insider* is continuing to highlight the financing options available through the *Tioga County Development Corporation (TCDC)*. In this edition you will learn more about the *Tioga County Micro Loan Program (TCMLP)*.

The *Tioga County Micro Loan Program (TCMLP)* is a low interest loan program designed to financially assist for-profit small businesses who are participating in small projects in Tioga County, Pennsylvania. The purpose is to create a positive, business-friendly economic climate to stimulate growth which will improve the overall economy of Tioga County.

The *Tioga County Loan Committee* and the *Tioga County Development Corporation* will **determine the interest rate for each loan origination based on ½ of the current prime rate with a floor of 3%**. The loan rate will be a fixed rate at loan commitment.

Projects up to \$25,000 are eligible for loans up to \$25,000. All aspects of business are eligible with the exemption of working capital.

The \$50,000 loan will be used towards the purchase of the former Laurel Lanes Bowling Alley and two (2) rental properties along with building repairs and upgrade of bowling lanes. The land is located at 299 Tioga Street, Borough of Wellsboro, Tioga County, Pennsylvania. Chambers opened on September 18, 2010 as Route 6 Lanes.

The Chambers Investments LLC is owned by William Chambers, Patricia Chambers and Michael Chambers. Chambers Investments brings over 33 years of business management experience to this new business venture.

The Chambers family is renovating all of the bowling alley's mechanical pinsetters, installing new digital automatic scorekeeping systems and opening a Mexican Restaurant. They also plan to update the interior design to be more modern and comfortable.



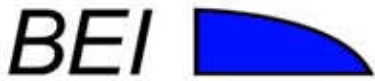

On Wednesday, December 8, 2010, John J. Trombetta, President/CEO of the Foundation For Free Enterprise Education (FFEE) presented Robert J. Blair, TCDC President/CEO a recognition plaque for the *Tioga County Development Corporation's* Outstanding Support of and Dedication to the mission and annual goal of Pennsylvania Free Enterprise Week 2010.

Twenty-four (24) students from our three (3) public school districts, Northern Tioga, Southern Tioga and Wellsboro Area School Districts, have graduated from the program and ten (10) business and organizations in Tioga County have provided funding towards scholarships. 2010 EITC Annual Report

Annually, The **Tioga County Foundation** allocates a portion of its received Education Improvements Tax Credit funds towards assistance with School-to-Work and Career Development programs in Tioga County's three public school districts. Once again in 2010, the Tax Credit program has been a huge success.

In 2010, The **Tioga County Foundation** received a total \$56,500 from Citizens & Northern Bank, First Citizens National Bank, Northwest Savings Bank and Ward Manufacturing LLC for which we were able to provide \$36,160.00 for 20 Projects to date. From January 1, 2010 through December 31, 2010 we leveraged \$88,006.95 from the Applicants for Total Projects Cost of \$124,166.95 ... Impacting 2,653 Students.

We want to thank the private companies who are supporting Career Development in our three Public School Districts with their EITC Contribution. We hope this program will continue to grow in Tioga County to assist our students as they prepare for the work force.

In this issue of our *eNews Insider* two areas are highlighted . . . our Loan Program and Youth Career Development. Our Revolving Loan Program continues to grow as more small businesses become aware of the availability of low interest fixed rate loans. Working closely with our private lenders we can provide a portion of the funding. We have introduced a new Micro Loan Program to assist small businesses with smaller projects. We can fund the entire project up to \$25,000 with the exception of working capital which is provided by the private sector. The interest in our loan programs is increasing and hopefully an indication of the upturn in our local economy.

We have been very active in a variety of career development opportunities for our youth. A countrywide Health Career Day was held in November with 35 occupations available for our youth to pursue. Health Care remains our large service employment sector providing over 1,000 jobs in our county. Several public and private organizations and businesses assisted in making the 2010 Tioga County Health Career Awareness Day a great success.

Our Leadership Tioga County *Youth Leadership Program*, in its 12th year, featured the Natural Gas Industry at the December 7, 2010 *Understanding Business & Economics*. Students had direct contact with some of the businesses involved in the industry. Each well involves over 150 job classifications and our youth have an opportunity to be employed in our county for their entire career.

Plans are underway for the **2011 Tioga County Energy Career Day** to be held on May 10, 2011 at Penn College. We will feature natural gas, electric and wind. It will focus around 10th and 11th grade students.

The Education Improvement Tax Credit Program was again successful in 2010. Thanks to the support of our private contributors several projects were undertaken in each of our 3 public school districts. *TCDC* is fortunate to have Christie Blackwell spearheading our Leadership and EITC Programs.

The Pennsylvania Free Enterprise Week under the direction of the *Foundation for Free Enterprise Education* was another great success in 2010. *TCDC* has always been a supporter and has encouraged Tioga County businesses to provide student scholarships.

As we near the completion of 2010, I want to take this opportunity to thank the Board of Directors; our staff, Carolyn and Christie, our Members and our businesses and organizations for all of your support during this difficult year. We have accomplished a great deal, but there is so much more which needs to be completed.
